ARTICLES OF INCORPORATION OF THE PMT DIGITAL CURRENCY

Definition and Constitution

The digital currency of the Popolo della Madre Terra -PMT- is hereby established (https://popolodellamadreterra.org)

It is called "LIBER" (excluding inverted commas) - PMT COIN (pron. Libér; valid: masculine and feminine) minted and issued on the blockchain TON (The open Network: https://www.ton.org) identified by contract address: --EQB5ImU9qS5qKVyMvTqmIdkl3m2dQKQzx1amfNmS52M4PD9J-- (hyphens excluded)

1 LIBER unit consists of one or more metals/minerals in quantities measurable in troy ounces

At the date of this deed the constituent metals are two: gold (Au) and silver (Ag)

The quantities of each metal are calculated with reference to the constituent quantities of minimum dignified life and well-being (henceforth also referred to as mvdb) as well as the percentage ratio between the metals, calculated in the same ratio as mvdb;

This calculation, as of the date hereof, results in the definition that in 1 LIBER unit there are approximately 1/1500 of each of the metals in mvdb, in troy ounces;

As of the date hereof, LIBER is in direct connection with mvdb, but is not dependent on it in any way or form

Stability Criteria

The criteria of stability are, at the date of this act, in direct correlation with those of a minimum of a dignified life and in well-being, the mechanism of which is nevertheless stated;

In order to guarantee stability in purchasing power for each member, it is necessary to stabilise the amount of reference metals and/or minerals;

The LIBER is monitored at regular intervals by an algorithm according to preset stability criteria;

The "established current quantity of constituent metals or minerals" is henceforth defined as "qsm" (without inverted commas)

The qsm of LIBER may have, second by second and instant by instant, a maximum over or maximum underpricing in the equivalent price expressed in one or more fiat currencies of reference, chosen by the algorithm;

Should this maximum excess or maximum deficiency be reached, the algorithm would subtract or add to the qsm of LIBER a troy ounce amount of constituent metal and/or mineral (one or more metals/minerals may be chosen by the algorithm) equal to a percentage necessary to balance the amount of constituent metals and/or minerals in pmt coin;

It is the algorithm that chooses from the constituent metals/minerals those to be added to or subtracted from the qsm according to internal criteria

Change and substitution

Every 7th of the month the Ministry of Finance revises and re-establishes the quantities of constituent minerals and/or metals in LIBER;

At any time as a result of excessive appreciation or depreciation of LIBER's constituent metals/minerals and/or the domestic and world economic and political situation, as well as emergency events, wars, famine and anything else that may affect the members' psycho-physical well-being and dignity, the Ministry of Finance may convene an emergency meeting to review, redefine and re-establish, replace the quantities and types of LIBER's constituent metals and/or minerals;

Metals and/or minerals contained in a LIBER unit may be substituted at any time as follows: (the following points refer to only one metal or mineral, but apply to several metals and/or minerals at the same time)

1. metal is identified

2. the metal to be replaced is temporarily pegged to a parameter (mainly fiat currencies) to lock in its price 3. a quantity of replacement metal is chosen with a price equivalent to that of the quantity of metal to be replaced at the time of pegging as in point 2

4. metal substitution

Coining

Coining is defined as the act of creating LIBER units directly from the Master contract address (see number at the top of this document) via the admin account;

The only legitimate form of LIBER minting is the one authorised by the Ministry of Finance of the PMT and only takes place if all points in the following procedure are fulfilled:

1 The Minister of Finance coins LIBER units via the admin account

2 The finance minister writes the minting document with the master contract address, the jetton wallet address, the admin address, the hash of the transactions on the blockchain, date and time of the transactions, the number of units LIBER

3 The Minister of Finance and the President validate the minting document by affixing their wet signature and fingerprint

4 The minting document is given in hard copy for safekeeping, authenticated by the Minister of Finance and the President of the PMT by means of wet signature and fingerprint, to members of the PMT previously appointed as "*custodians of the minting documents and wallet*" (note 1)

5 The minting document is made public within the Ministry of Finance only and exclusively on the page dedicated to the PMT digital currency issues, that at the time of this deed is the following:

https://popolodellamadreterra.org/ministero-delle-finanze/dispensa/prezzo-attuale.aspx (the change of the link of the page is valid only and exclusively if it is approved by signature and imprint of the PMT President and the Minister of Finance and published within the page of the deeds in the Ministry of Finance)

The minting act is repeatable and the LIBER "re-mintable"

Issue and wallet

Issuance herein means, the act that the Minister of Finance performs, in transferring LIBER units from the jetton wallet and/or admin wallet to the distribution wallet and from the distribution wallet, to the wallets of the PMT Ministries; The identifiers of the wallets of each Ministry, including address and details, are published on the authorised wallets page in the Ministry of Finance, in the "authorised wallets" section in this Act or in a document validated and approved by the Minister of Finance and the President of the PMT, by wet signature and fingerprint.

Such document shall be given in hard copy for safekeeping, authenticated by the Minister of Finance and the President of the PMT by wet signature and fingerprint, to members of the PMT previously appointed as "*custodians of the minting and wallet documents*" (note 1)

Transfers of LIBER units from each ministry's wallet to another wallet are authorised and valid only if: - Reported within the Ministry of Finance issue page with: transaction hash and transaction link, date and time, LIBER unit number, destination wallet address

-Reported within the telegram channel with the identifier: https://t.me/+Po0w7AQNtjQ5ZGRk with transaction hash and transaction link, date and time, LIBER unit number, destination wallet address

Assignment, distribution, transfer and use

The LIBER is assigned, distributed and transferred without security to the owner

The assignment is free of contracts

Transfer gas is the responsibility of the sender, and is payable in Toncoin TON as of this deed

As of the date of this deed and until subsequent revisions, LIBER may only be used within the official PMT site (https://popolodellamadreterra.org), between full members (with validated sovereignty declaration in the presidency), outside the PMT only if authorised by the Ministry of Finance in the document "monetary authorisations"

The following points are to be considered permitted and valid only if authorised by the Ministry of Finance in the document "monetary authorisations":

- trading outside the PMT and between members and external entities

- any form of exchange or swap between non-members, and between members and entities outside the PMT
- financial and/or leveraged trading
- distribution to entities outside the PMT

The PMT reserves the right to annul and void any transfers that do not comply with this document, and tag the relevant wallet as "untrusted", following which the underlying direct transfers in the transaction tree will also be tagged as such, as will any related wallets;

Such transfers and wallets will be listed as unauthorised on the issues page

The wallets: ADMIN, JETTON, DISTRIBUTION, MINISTRY OF FINANCE AND THE PRINCIPAL OF EACH MINISTRY may receive transactions and/or incoming transfers only from the above direct wallet and only and exclusively in Toncoin TON or LIBER, furthermore only those listed in this section below are authorised and valid;
